



Ensure all payment terminals are foolproof - Point of sales terminals are usually a target point in small - and medium-scale enterprises, it is therefore very important that all payment terminals are monitored and secured to ensure that they are not hacked into and customers' details are not harvested through them, and to avoid any resulting loss of enterprise reputation.

How to advertise and sell fairly during holiday sales

As we approach the busy holiday season, it's important to remember what your business can and can't do when advertising and selling goods and services. These rules apply to claims made in-store and online, such as testimonials on your website or social media pages. Some reminders to help your business comply with the law are [here](#).



Do you work with more than one workspace on your desktop?

To create a new workspace - click on Windows and Tab / click on 'New desktop' to add a fresh workspace / to switch between desktops: press Windows plus Ctrl and right or left arrows to switch between.

To underline text – highlight text and: Ctrl + Shift + D for double underline / Ctrl + U for single underline / Ctrl + Shift + W to underline, to leave a space between the words.



Tip: When using Word

To change font size incrementally – Highlight the text, hold Ctrl and Shift, and use the right arrow to increase and the left arrow to decrease.



Quick tricks in Excel

To auto-fit content in columns – right click on the sheet number at the foot of the page / select 'View Code' / switch from General to Worksheet / enter the code - Columns.AutoFit. Go back to the worksheet, and the column width will adjust to fit whatever you type.
To add check boxes – highlight the appropriate cells. Hold Alt and type N C B. Done. To tick a box, just click on it ... easy!

ATO warning for 'freeloading' tax dodgers

The Australian Taxation Office (ATO) has blasted "freeloading" individuals and businesses who are dodging their tax obligations. the tax office receives nearly 1,000 tips-offs each week about tax avoidance and has warned it will discover if you are doing the wrong thing. They hit a major milestone of more than 300,000 tip-offs from the community about tax avoidance and dishonest behaviours since July 2019. Most of these are related to shadow economy activity, such as demanding cash payment for work or incorrectly claiming business expenses [Article](#).
